Even in times of procurement, the undertaking of a strengthening project can facilitate a smoother migration, along with providing an interim solution until a new system is available for deployment.

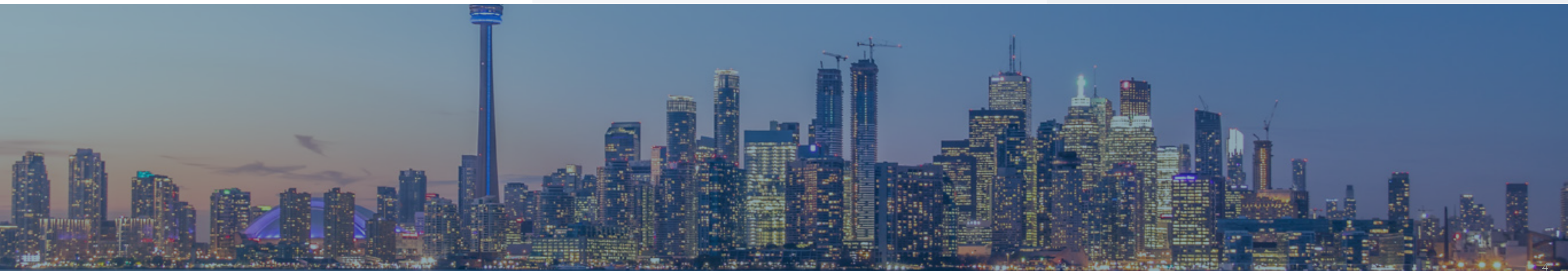
